What is the focus of Aetna Specialty Pharmacy?

Aetna Specialty Pharmacy focuses on providing injectables and specialty medications while delivering quality customer service and clinical support to you and your patients.

Is my patient or am I required to use Aetna Specialty Pharmacy?

While patients may be able to use other specialty pharmacies under certain circumstances, Aetna Specialty Pharmacy is the in-house specialty pharmacy for Aetna members. Also, depending on your patient's benefits plan, he or she may be able to go out of network. However, this could result in a higher copayment, additional expenses, or non-coverage.

Do I need to bill for these medications?

No, you do not need to submit claims for specialty medications obtained from Aetna Specialty Pharmacy. Our insurance specialists will handle all billing and claims according to the patient's benefits plan.

How long will it take to receive my order?

When you use Aetna Specialty Pharmacy, a complete order is delivered within 24 to 48 hours of confirming it, or as scheduled to meet your patient's needs. If a prescription is missing information or if it requires precertification, this can impact your delivery time.

What support services do patients and health care professionals receive from Aetna Specialty Pharmacy?

Patients receive the full support of our clinical staff, including pharmacists, registered nurses, certified pharmacy technicians and regional clinical liaisons. These clinicians are available 24 hours a day, 7 days a week through our toll-free number.

In addition, the Aetna Specialty Pharmacy team will coordinate prior authorizations, case management, home care, condition specific education and clinical support to help your patients achieve the best possible results from their therapy. We are also available to assist in dosing calculations and to address other pharmacological questions.
